Sub: Preliminary Test for Admission to SAS Part-I examination to be held on 18th April, 2016 (Monday) – Issue of Roll Numbers.



2. **Annexure 'A'** shows the names of **141 candidates** of this organization who have been permitted by HQrs office to appear in aforesaid exam at Meerut & Other Centre and **Annexure 'B'** showing the names of **35 Candidates** serving under other organizations, who are permitted to appear at **Meerut Centre**.

Any corrections thereto deemed necessary, either in regard to the names of candidates, section in which they wish to appear in Paper 2 (Part 'A' – Common to all – Section-I) and Part 'B' ARMY (Section-II), Air Force (Section-III), Navy (Section- IV) and Factory (Section-V) portions, as the case may be or place of examination, may please be apprised to this office immediately on priority and not later than **23rd March 2016**. A **'NIL'** report may also be furnished.

The candidates may be asked to present in the Examination Hall **HALF-AN-HOUR BEFORE THE COMMENCEMENT OF THE EXAMINATION** in each paper along with their respective **Identity Card** so that they can complete the required details on the Question Booklets as well as on the Answer Sheet by filling the relevant boxes. Candidate will be allowed to leave the examination hall only after the completion of two hours of examination.
5. Both the Question Booklets and Answer Sheets are required to be handed over by the candidates to the conducting officer before they leave the Examination Hall. This fact may brought to the notice of the candidates while circulating the Roll Numbers.
6. It may be brought to the notice of all the candidates that for darkening of the circles of answer sheets (OMR) Black Ball Point pen only is to be used. Use of Pencil to darken the circles is strictly prohibited.
7. Further, in order to ensure transparency & fair conduct of examination, it has been decided by the Competent Authority to Video-graph the entire proceedings of each session of the examination during the examination. This may be brought to notice of all the candidates.
8. All concerned individuals may please be informed accordingly and their dated signatures in token of having noted their Roll Number and Centre may please be obtained and kept on record.
