Subject: Delay in issue of LPC / Non-linking of LPC - reg

Of late, the following discrepancies / shortcomings have been noticed in issuing of LPCs in some of the Controllers' Offices:

- (i) Salary is being paid to the officers and staff even after their relieving from the concerned office.
- (ii) LPC is not being issued immediately after relieving of the officers / staff.
- (iii) In some cases copy of the LPC is not endorsed to the officers / staff concerned.
- (iv) Linking of LPC not monitored properly thereby credit / debit reflected therein remain unadjusted.
- (v) Proper distribution of pay slips are not ensured, especially at the time of relieving of officers / staff from the office concerned.
- (vi) The lapses / observations mentioned above results in over payment in certain cases as outstanding dues are not recovered in time.

2. In this connection all PCDA / CDA Offices are hereby requested to issue appropriate instructions to ensure for compliance of the provisions contained in para 392 of OM Pt.II, Vol-I and orders issued from time to time.
