A statement showing the names and Roll numbers allotted to the candidates who have been permitted to appear in SAS Pt-I Examination scheduled to be held from 5th May to 8th May 2015 and the stations at which they have to appear in the examination, is enclosed. The information is also available in CGDA's Website.

2. **Annexure 'A'** shows the names of 34 candidates of this organization and 18 Candidates serving under other organizations (**Total 52 candidates**) who are permitted to appear in SAS Part-I examination at **Meerut Centre**. **Annexure 'B'** shows the names of **10 candidates** of this organization who are permitted to appear in SAS Part-I examination other than Meerut Centre (**Lucknow-01, Jaipur-03, Kanpur-01 Dehradun-05**).

3. Corrections, if any, specifically in Name/Grade/Account No./Category/Centre/Section/ Hindi Option/Exemption etc. may be verified and informed immediately to this office so that the same may be forwarded to HQR's Office for carrying out necessary amendment thereon.

4. SAS Examination Pt-I will be held at **Unity Hall, CDA (Army), Belvedere Complex, Ayudh Path, Meerut, Pin code : 250001** on the dates as per programme indicated vide this office Circular No. **NO.AN/VI/3205/SAS-I/May/2015** dated 16/03/2015 who have opted for Meerut Centre.

Venue for Lucknow, Jaipur, Kanpur and Dehradun centres will be intimated to the concerned candidates immediately after receiving the same from the Hqrs. Office/concerned PCDA/CDA.

5. The candidates are advised to be present in the Examination Hall **HALF-AN-HOUR BEFORE THE COMMENCEMENT OF THE EXAMINATION** in each paper. There is no change in the timings of the examination. The examination will start from 10:00 A.M and will end at 01:00 P.M for each Paper (each day)

6. As per SAS Rule 14 (b), each permission to appear in SAS part I or Part II examination will count as one chance against the respective part, whether he/she actually sits for the examination or not unless he/she is specifically allowed to withdrawal his/her name by the CGDA. In accordance with the ibid proviso read with SAS Rule 14 (d), withdraw of the candidate not submitted within laid down time period would count as a chance. It may be clarified that as per decision of MoD(Fin), withdrawal of a candidate on medical ground after commencement of examination would also count as a chance. As such, failure to appear in this examination by way of absenteeism or medical ground after commencement of examination will entail forfeiture of one of the four valuable chances allowed to the candidates as per revised SAS Rules. The candidates may be informed accordingly.

7. Further, in order to ensure transparency & fair conduct of examination, it has been decided by the Competent Authority to Video-graph the entire proceedings of the examination during all five papers. This may be brought to notice of all the candidates.

8. All concerned individuals may please be informed accordingly and their dated signatures in token of having noted their Roll Number and Centre may please be obtained and kept on record.
