Sub.: Transfer Policy – Positng of Sensitive Assignment.

Ref.: This office letter no. AN/1/1175/Sensitive dated 12.07.2022.

The following amendment is carried out in the letter cited under reference at Para 2.1, 2.2 & Para 4.2 of Sensitive Assignment policy in respect of staff/ officers upto AAOs:-

Para 2.1

For: While making seniority preference will be given to APAR grading (Auth. 0600/AN-X/Vol-XI dated 28.03.2014). Six month weightage will be given to all “outstanding” APARs and three month weightage will be given to two outstanding APARs.

Read: Six month weightage will be given to all “outstanding” APARs,
Four month weightage will be given to two outstanding and one very good APARs.
Three month weightage will be given to one outstanding and two very good APARs.

Para 2.2

For: Second preference will be given to never served officials.

Read: (i) Annexure ‘A’ (Officials who have “Never Served”): First preference will be given to these officials.
(ii) Annexure ‘B’ (Officials who have “Once Served”): Second preference will be given to these officials, if eligible individuals in Annexure ‘A’ are not available.
(iii) Annexure ‘C’ (Officials who have “Twice Served”): Third preference will be given to these officials, if eligible individuals in Annexure ‘A’ and Annexure ‘B’ are not available.

Para 4.2

For: If a person who has been selected for the sensitive assignment shows his/her UNWILLINGNESS to join a sensitive assignment and FOREGO the sensitive assignment, he/she would be DEBARRED for the sensitive posting for THREE years from the date of rejection & he/she will be posted out to another station.

Read: If a person who has been selected for the sensitive assignment shows his/her UNWILLINGNESS to join a sensitive assignment and FOREGO the sensitive assignment, he/she would be DEBARRED for the sensitive posting for THREE years from the date of rejection and

- (a) If, he/she has served in the station for less than 03 years, he/she may be posted out to another section/office in the same station as per administrative feasibility.
- (b) If, he/she has served in the station for more than 03 years, he/she may be posted out to another station under the administrative control of CDA (Army) Meerut or otherwise as per administrative convenience & feasibility. Decision of CDA would be final.
- (c) In exceptional circumstances, if he/she had been assigned technical nature of job/any important assignment then his/her Placement/Posting will be considered as per recommendation of G.O./S.A.O./A.O./A.A.O of his/her section/office as per the administrative compulsions.

All other data remains the same.
