

Sub: Excess booking under Salary & Allowances Head.

In continuation to this HQrs letters of even No. dated 22,02.2024 and 06.03.2024, it has been observed in the preceding week that the Field Controllers are not maintaining discipline with regard to incurring of expenditure and booking thereof with reference to the allotments made both under Centrally Controlled Heads and Locally Controlled Heads. In heads like Salaries and Allowances, many Field Controllers have booked expenditure beyond the allotments leading to negative/minus balances in these important and Centrally Controlled heads. The HQrs office had to carry out major adjustments between funds available with other Field Controllers to even out the minus balances.

- 2. It is also intimated that after carrying out close monitoring of expenditure and review of balances, **final surrenders** have already reported to the Ministry of Defence (Finance), which have been accepted. They have further intimated that no surrenders will be accepted by MoD (Fin), hence there would be no scope for minus booking in any of the heads.
- 3. Accordingly, all Field Controllers are hereby advised that due diligence may be carried out while incurring expenditure and compilation of the same strictly with

reference to Budget available at their disposal in the respective code heads. While funds available are necessarily required to be exhausted/utilized before the eno_f Current Financial Year (CFY), no negative/ minus booking will be acceptable in any of the heads beyond the allotments so made. Negative booking now reported will be treated seriously and the concerned officers/functionaries dealing with expenditure and compilation will be liable for suitable disciplinary action.
