

Sub: DPC for promotion of AAOs to the grade of SAO(Group-A)

Please refer to HQrs Office letter no AN/II/2151/DPC/AAO tyo SAO/2024 dated 23.11.2023 wherein it has been mentioned that as per the draft Recruitment Rules of SAO, one of the eligibility conditions for promotion to SAO grade is that AAO has successfully completed mandatory training of 02 weeks in RTCs or any other recognized Institute. Further, it also been directed in the ibid letter that all the eligible AAOs, falling under the zone of promotion to SAO grade, may be instructed to mandatorily attend the said training course (including those who are currently on long leave etc) failing which they will not be considered eligible for promotion to the grade of SAO by the DPC.

2. In view of above, it is therefore requested that contents of the above circular may please be brought to the notice of all concerned and also get it noted from them. The AAOs who are currently on leave may be apprised through their official email/correspondence address.
