Sub: Fixation of pay on promotion within the same pay level from Sr. AO (Level-10) to JTS of IDAS (Level-10)

This HQrs. has received a case containing a point of doubt regarding the method of fixation of pay on promotion from SAO (Level-10) to ACGDA/ACDA (Level-10). In this connection, the following is clarified:-

2. The pay fixation on promotion from Sr.AO (L-10) to ACDA (L-10) is carried out under Rule 13 of CCS (RP) Rules 2016 in terms of MoF, Department of Expenditure OM No. 10/02/2011-E.III/A dated 07.01.2013. Further DoP&T vide its OM No.13/02/2017-Estt.(Pay-1) dated 27.07.2017 has issued clarification regarding availability of option for fixation of pay on promotion from the DNI in the lower post and method of fixation of pay from DNI.

3. Since the DoP&T OM dated 27.07.2017 simply states that pay of the Government servant shall be placed at next higher cell in the intervening period, the OM does not make a distinction between promotions in same or higher pay levels. Thus, if the officer opts for pay fixation from his DNI, he should be placed in the next higher cell during the intervening period i.e. from the date of his promotion till his DNI even though the promotion may be in the same Pay Level-10 and thereafter his pay may be fixed on DNI as per the ibid OM dated 27.07.2017 and Rule 13 of CCS (RP) Rules 2016.
