The University of Delhi wishes to appoint two Assistant Internal Audit Officers, on deputation basis. Further there would be one more vacancy for this post. The office of Internal Audit is expected to be supervised by an officer with strong financial background and therefore, preference shall be given to an officer of organized services as per the Recruitment Rules detailed below. Therefore, it is expected that the officer shall possess the qualities of being honest, competent and dedicated to his work. The post shall be on deputation basis with maximum tenure of one to two years, which could further be extended as per administrative requirement.

Recruitment Rules for the post of Assistant Internal Audit Officer provide for qualification as under:

From amongst the Officer of any of the Organized Account Cadre/ Service

(a) For the pay scale of Pay Level 11

From amongst the Officers from any of the Organized Account Cadre/Service in the pay scale of Pay Level 11

OR

in the pay scale of Pay Level 10 and having minimum 02 years' experience in Pay Level 10.

(b) For the pay scale of Pay Level 10

From amongst the Officers from any of the Organized Account Cadre/Service in the pay scale of Pay Level 10.

OR

in the pay scale of Pay Level 09

OR

in the pay scale of Pay Level 07/Pay Level 08 having minimum 3 years experience in Pay Level 07/Pay Level 08.

It is requested that this may be circulated among the departments of your organization and a panel of eligible and suitable officers having requisite experience may kindly be forwarded to the Registrar, University of Delhi, Delhi - 110007 latest by **13.02.2023** in enclosed proforma with their details of service, experience and ACRs/APARS for the preceding five years.

Since the University is interested in experienced officers, completion of age of 57 years is not a bar. The University will appreciate if additional names are also provided for preparation of panel.
