In this context, it is stated that guidelines for running defence shopping complexes and Unit (Regimental) shops on defence land and crediting of revenue generated to Govt. treasury and Regimental funds is under examination of Ministry of Defence.

As there is an inadequate recovery of licence fee and non deposit of rebate realized from shopkeepers occupying shops located in defence land and buildings in Public fund, whether it is from shopping complexes or Unit shops (Regimental shops); there is a need to have a comprehensive data with regard to recovery of LF and Rebate and deposit thereof so that matter may be taken up with the Ministry of defence.
