2. **SAS Examination Pt-II** will be held at UNITY HALL, CDA (ARMY), Belvedere Complex, Ayudh Path, Meerut Cantt. Pin-250001. On the dates as per programme indicated vide this office Circular No. VI/3205/SAS/PART-II/DEC/2016, Dated 19/09/2016, who have opted for Meerut Centre.

Venue for Dehradun centre will be intimated to the concerned candidates immediately after receiving the same PCDA(AF), Dehradun .

3. The candidates would come prepared to produce their IDENTITY CARD/IDENTITY CERTIFICATE issued by their Office at the gate before entering the examination Hall. The candidates are advised to be present in the Examination Hall HALF-AN HOUR BEFORE THE COMMENCEMENT OF EXAMINATION in each paper. The Examination will start at 10:00 A.M. and will end at 01:00 P.M for each paper (each day) except for IX, which will start at 10 A.M and will end at 01.30 P.M.

4. As regards candidates from other controllers, their specimen signature taken on the profoma appended below, duly attested by the Officer-in-Charge under whom they are serving, should be forwarded to this office immediately.

5. All concerned individuals(including those on leave) should be informed to bring their own sets of Books (authorized Only) on the dates of practical paper (Paper V with Books) as normally it will not be possible to supply books to all the candidates.

6. As per SAS Rule 14(b), each permission to appear in SAS Part-I or Part-II examination will count as the chance against the respective part, whether he/she actually sits for the examination or not unless he/she is specifically allowed to withdraw his/her name by the CGDA. In accordance with the ibid proviso read with SAS Rule 14 (d), withdrawal of the candidates not submitted within laid down time period would count as a chance. It may be cleared that as per decision of MoD (Fin), withdrawal of candidates on medical ground after commencement of examination would also count as a chance. As such, failure to appear in this examination will entail forfeiture of the four valuable chances allowed to the candidates as per revised SAS Rules. It may be further clarified that under no circumstance request for withdrawal in respect of candidates availing special chance will be accepted. The candidates may be informed accordingly.

7. Further in order to ensure transparency & fair conduct of Examination, it has been decided by the Competent Authority to video-graph the entire proceedings of the Examination during all five papers. This may also be brought to notice of all the candidates.
