TERMS AND CONDITIONS FOR SALE OF OLD VEHICLE BY CDA (RTC), MEERUT: MITSUBISHI CANTER (25 + 3) SEATER BUS BEARING REGISTRATION NO. (UP15 C2747) Model: 1993

Interested Parties may submit their highest price for the vehicle in a sealed cover latest by 1500 Hrs on **02.05.2019**. The inner cover containing quotations and other relevant documents along with DD/Pay Order towards Earnest Money Deposit (EMD) should be sealed properly. The inner cover should be put in on outer cover and may be dropped in the box kept at the Reception of o/o the CDA (RTC), Belvedere Complex, Ayudh Path, Meerut Cantt. Both the inner and the outer covers should be superscribed in bold Capital letters "QUOTATIONS FOR SALE OF OLD VEHICLE OF CDA (RTC), MEERUT". **The bids will be opened at 1600 Hrs on 02.05.2019 at o/o the CDA (RTC), Meerut.**

2. The disposal of vehicle shall be strictly on "**AS IS WHERE IS BASIS**" and no guarantee or certificate of its worthiness or quality will be given by o/o the CDA (RTC). The condition of the vehicle can be inspected physically on any working day during 11 A.M to 4 P.M between 23.04.2019 to 01.05.2019 by contacting Sr AO (AN), o/o the CDA (RTC), Meerut. Tender forms with terms and conditions for submitting tenders can be obtained from the above officer on payment of Rs 100/- (Rs hundred only) (Non-refundable) for each set of forms on any working day during 11 A.M to 4 P.M between 23.04.2019 to 01.05.2019 or may be downloaded from the website having URL: <http://cdaarmymeerut.nic.in/rtc.php> free of cost.

3. The quotation should be accompanied by earnest money i.e. Rs 5,000/- (Rs. Five thousand only). The earnest money is required to be deposited in the form of Bank Draft issued in favour of "*CDA (ARMY), MEERUT*". The bank draft should be attached with the quotation letter failing which the quotation shall not be considered at all. If the HIGHEST TENDERER/SUCCESSFUL TENDERER accepted by the Competent Authority fails to deposit the sale price within the prescribed time limit i.e. within 7 working days from the date of intimation to the tenderer(s) declared as highest bidder by the Competent Authority, his earnest money will be forfeited. In case the offer is withdrawn by any tenderer, the earnest money deposited by him shall be forfeited.

4. EMD of Rs. 5,000/- for the said vehicle is payable by means of DD/Pay Order in favour of "*CDA (ARMY), MEERUT*". (Payment by Cheque/Cash shall not be accepted). Offers received without EMD amount shall not be considered at all by this Office.

5. EMD of the successful bidders(s) will be released only after realization of Sale proceeds amount. Earnest money Deposit of the bidders who fail to honour the bid in prescribed time limit shall stand forfeited. No representation in this regard shall be entertained by the CDA (RTC), Meerut. EMD amount of **H₁** bidder shall be adjusted in the Sale Amount accepted. EMD of unsuccessful bidder(s) shall be released only after successful completion of the sale process.

6. The delivery of the sold vehicle will be made only after realisation of entire sale price and submission of documentary evidence in support of

residential status (Ration Card/ Voters Identity Card in case of individual and Registration Certification in case of firms etc.) by the successful bidder.

7. The sold vehicle will be removed by the successful bidder(s) within 7 days after the date of issue of letter of delivery by o/o the CDA (RTC), Meerut on receipt of full amount of consideration. No assistance/transportation will be provided by o/o the CDA (RTC), Meerut. Permission to take out the disposed vehicle from premises will not be allowed on holidays, Saturdays and Sundays etc.

8. It will be the sole responsibility of the buyer for getting the necessary paper works done in accordance with the law and as per the provisions of the Motor Vehicles Act (amended from time to time) applicable for Transport Authority of Govt. of UP. This office will not be responsible for any lapse on the part of the buyer in this regard.

9. EMD of the firms rescinding their offer, withdrawing or abrogating after submitting the bid shall stand forfeited. Decision of the CDA (RTC), Meerut shall be final in this regard.

10. The CDA (RTC), Meerut reserves the right to reject all or any tender in whole or part without assigning any reasons thereof.
